Of course you cannot claim the code was fully written by yourself in this case, so you'll probably have to retain it in source somewhere, but i.e. you don't need to include my above BSD 3-clause notice into any binary distributions / webpages / whatever when reusing just code marked for full availability.

Third-party software used in TrayBrowser

As TrayBrowser project is overall a complex product integrating third party libraries of much higher scale than the project itself, BSD 3-clause license applies only to its directly authored part.

For all the third party projects and dependencies used in making TrayBrowser possible, their respective licensing terms follow.

Take care no third party products code was directly modified for building TrayBrowser, and thus these projects code is not distributed alongside (with the only exception of FPC ZMQ bindings, it being a single small file viable to include directly) and can be found on respective projects home sites and public repositories.

Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Library General Public License, applies to some specially designated Free Software Foundation software, and to any other libraries whose authors decide to use it. You can use it for your libraries, too.

When we speak of free software, we are referring to freedom, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish), that you receive source code or can get it if you want it, that you can change the software or use pieces of it in new free programs; and that you know you can do these things.

To protect your rights, we need to make restrictions that forbid anyone to deny you these rights or to ask you to surrender the rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library, or if you modify it.

For example, if you distribute copies of the library, whether gratis or for a fee, you must give the recipients all the rights that we gave you. SQLite Is Public Domain
